- * All quilts must remain on display for the duration of the requested time - 3-4 months.
- * Quilts may be offered for Sale. Exhibitor will provide the price. EMQS will retain a 10% commission if the quilt sells. Exhibitor will pay EMQS a 10% commission if the quilt sells after the hanging to a purchaser who chose it because of seeing it hanging at Whitefish Credit Union.
- * Quilts may be photographed by visitors and the media. Quilt registration constitutes permission by the entrant to use photographs for publicity purposes by Whitefish Credit Union and/or Eureka Montana Quilt Show.
- * Eureka Montana Quilt Show reserves the right to select and plan each display.
- * **Credit must be given to the author, teacher, artist, etc. who inspired the work.**
- * The Whitefish Credit Union and the Eureka Montana Quilt Show assume NO responsibility in damage / loss and accepts no liability. We WILL take care of your quilt. Remember that accidents may happen.
- * Quilts selected for each viewing time will be notified, and the time & place of delivery will be provided.

I agree to allow photography of my quilt.
